Dear Chief Justice Cherry:

The Nevada Bar Foundation was recently saddened by the loss of one of its Trustees, Kirk Jacobson. The Court appointed Kirk to the Foundation's Board of Trustees in 2014 and his contributions to the Board will be missed. I submit this letter to the Court as a formal request to appoint a Trustee to serve as his replacement for a two-year term commencing January 2018.

The Foundation respectfully requests the Court appoint Sarah Guindy to fill the vacancy left by Mr. Jacobson. Ms. Guindy currently serves as the Executive Vice President of Bank of Nevada and is familiar with the IOLTA program. Her service to the Foundation will be beneficial to the Foundation as we seek to strengthen our banking relationships.

The State Bar of Nevada's Board of Governors also made two appointments to the Board of Trustees following the resignations of James Bradshaw and Rick Pocker. The Board of Governors elected to appoint Mark Brandenburg, Chairman of Freemont Street Experience and Kelley Jones, Deputy Public Defender for the Clark County Public Defender, as their replacements.

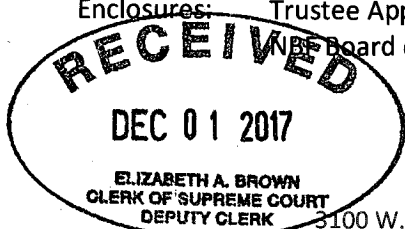
On behalf of the Nevada Bar Foundation, I thank the Court for the opportunity to support this important program. I am available to answer any questions.
