The Court sentenced Petitioner to imprisonment in the Nevada State Prison for a minimum term of twenty-four (24) months to a maximum term of seventy-two (72) months and by payment of a fine in the amount of five thousand (\$5,000.00) dollars on Count I; a minimum term of sixteen (16) months to a maximum term of seventy-two (72) months in Nevada State Prison on Count II, to run consecutively with Count I.

Petitioner claims that the sentence is working to the Petitioner's extreme detriment, and was illegally enhanced.

2.	burglary by forgery, the proper crime should have been petty larceny. Uttering forged
3	checks for an amount under two hundred fifty (\$250.00) dollars does not fall under the
