ORDER

The Court has read and considered the legal memoranda and exhibits submitted in support of and in opposition to Defendants' *Motion to Dismiss*, filed on August 3, 2005. By presenting an affidavit in support of their argument, the Defendants have offered matters outside the pleadings. Therefore, it shall be treated as a motion for summary judgment under the standards of N.R.C.P. 56. *See N.R.C.P. 12(b)*.

Pursuant to Nevada law, "[s]ummary judgment is properly granted when, as a matter of law, the moving party is entitled to judgment because there are no genuine issues as to any material fact." *Prostack v. Songailo*, 97 Nev. 38, 40 (1981). Notably, a "genuine issue of material fact is where the evidence is such that a reasonable jury could return a verdict for the nonmoving party." *Posadas v. City of Reno*, 109 Nev. 448, 452 (1993). However, "[t]rial judges are to exercise great caution in granting summary judgment, which is not to be granted if there is the slightest doubt as to the operative facts." *Id.* When considering the propriety of granting summary judgment, the district court should construe the "pleadings and documentary evidence" in a "posture which is most

favorable to the party against whom the motion for summary judgment is directed." *Butler v. Bogdanovich*, 101 Nev. 449, 451 (1985).

Plaintiff contends that the Defendants either, severally or in concert with one another, obtained property that was rightfully his. In his complaint, the Plaintiff listed the items at issue along with their proximate value. In total, the Plaintiff contends the property at issue is worth approximately \$9,000.00. The most expensive piece of property that Plaintiff contends Defendants stole is a Rolex watch, which he values at \$3,000.00.

In the present motion, Defendants present an affidavit submitted by Travis Volpicelli,
Plaintiff Ferrill Volpicelli's and Defendant Lori Inman's son. In his affidavit, Travis Volpicelli
affirms that he collected the Plaintiff's watch, along with other personal effects, from the Washoe
County Jail upon the Plaintiff's arrest. The affiant further affirms that he pawned the watch himself.
The affiant is not a party to this case. Plaintiff does not refute the truthfulness of the affidavit, but
merely points out that discovery is ongoing and the affiant is the son of one of the defendants.
Plaintiff is representing himself in this matter and the Court generally affords a certain degree of
leniency to pro se litigants. Plaintiff, however, has failed to refute the Defendants argument
regarding the watch, but merely attacked the motion on procedural grounds. As such, even taking all
pleadings and documentary evidence in the light most favorable to the Plaintiff, this Court does not
find any genuine issue of material fact exists as to the watch. Therefore, Defendants are entitled to a
judgment as a matter of law. As the Defendants never came into possession of the watch, Plaintiff's
claim that Defendants embezzled his Rolex watch is dismissed.

Plaintiff's initial claim was for approximately \$9,000.00. At the time this case was filed, the justices' courts had jurisdiction personal property claims not to exceed \$7,500.00. As such, jurisdiction in this Court was proper. The dismissal of Plaintiff's claim for damages regarding the watch, however, reduces his overall claim to approximately \$6,000.00. Further, as of January 2005, the jurisdictional limit for the justices' courts was increased to \$10,000.00. According to N.R.S. 4.370(1)(e), justices' courts have jurisdiction over "actions to recover the possession of personal property, if the value of the property does not exceed \$10,000.00."

Accordingly, Defendant's *Motion to Dismiss* Plaintiff's claim that Defendants unlawfully obtained his a watch is GRANTED; it is further

ORDERED that Plaintiff's case be dismissed without prejudice so that he may file in an appropriate court having jurisdiction.
