## Points and Authorities


Facts demonstrating extraordinary relief is warranted:

1. Petitioners filings are not being timely processed, filed or returned, See docket reflecting several documents all filed on July 7 2017 despite being mailed over a ten day period.
2. ORDER GRANTING INJUNCTION AND RESTRAINING ORDER Granted on MARCH 14 2017 to date has not been received by Plaintiff.
3. MOTION to stay judgement and for injunction while ORIGINAL WRIT Proceedings resolve, mailed for filing on or about May 25th 2017 has to date not been filed in the lower court, nor has the file stamp copy been returned.
4. EMERGENCY Notice of MOTION AND MOTION FOR INJUNCTION AND RESTRAINING ORDER NRCB Rule 65 mailed to the Clerk on or about 7-24-17 to date has not been filed nor a return file stamp copy received.
