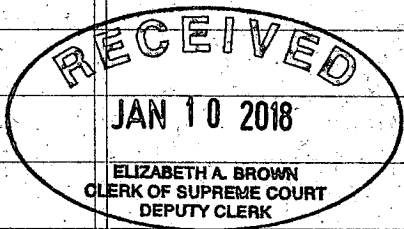


## Points and authorities


