<u>ARGUMENT</u>

On July 20, 2023, this Honorable Court issued an Order Affirming in Part and Reversing in Part the appeal submitted on behalf of Mr. Young. After reviewing the Order, prior attorney Jason Margolis, Esq. determined that a Petition for Rehearing is necessary.

NRAP 40(a)(1) provides that a petition for rehearing may be filed within eighteen (18) days after the filing of the Courts decision. NRAP 16(b) allows this Court to enlarge the time prescribed upon a showing of good cause.

Under the time frame set forth above, Mr. Young's Petition for Rehearing will be due by Monday, August 7, 2023. However I have recently been appointed to this case on July 26, 2023 given Jason Margolis has accepted an employment opportunity at the State of Nevada Attorney General's Office and Nancy Lemke with Southern Nevada Legal Aid Center.
