The district court entered a written order granting Respondent Polymer80, Inc. a preliminary injunction against enforcement of Section 3.5 of Assembly Bill 286 on July 16, 2021. Appellants appealed the district court's order on August 18, 2021.

The case proceeded before the district court. Following discovery and cross motions for summary judgment, the district court entered summary judgment (including a permanent injunction) against enforcement of Sections 3 and 3.5 of Assembly Bill 286.

Appellants intend to appeal the district court's judgment for similar legal reasons as this appeal. However, because the district court's preliminary injunction is no longer in effect, Appellants submit that the object of this specific appeal is now moot. *Matter of W.N. Connell & Marjorie T. Connell Living Tr.*, 133 Nev. 137, 142, 393 P.3d 1090, 1094 (2017) (observing that a preliminary injunction merges into a subsequent final judgment such that an appeal from the order granting preliminary injunctive relief becomes moot)

For the foregoing reasons, this appeal should be dismissed as moot, with no prejudice as to any appeal Appellants will pursue against the more recent summary judgment and permanent injunction.
