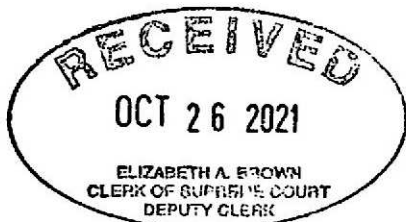
**Motion for Appointment of Counsel**




**Points and Authorities**
