## **DECLARATION OF NANCY M. LEMCKE**

- 1. I am an attorney licensed to practice law in the State of Nevada; I am handling the appeal of this matter; I am familiar with the procedural history of this case.
- 2. The Notice of Appeal was filed by David Fischer, Esq., on July 15, 2021.
- 3. Approximately two months later, I was appointed to represent Andrew Young on appeal. On September 22, 2021, I filed a Notice of Appearance before this Honorable Court.
- 4. On October 5, 2021, I submitted a Stipulation to enlarge the time for filing the Opening Brief. Pursuant to that Stipulation, this Honorable Court entered an Order setting a deadline of December 17, 2021 for the filing of the Opening Brief.
- 5. The final transcripts were not filed until November 1, 2021. Shortly thereafter, the Appendix was assembled and Bates stamped.
- 6. The Appendix consists of seven volumes and over 1300 pages of transcripts and other material. Significantly, Appellant was convicted of over 20 felony offenses, several of which resulted in habitual criminal adjudications. Appellant received multiple, consecutive, 10-life sentences on those habitual criminal adjudications.
