MEMORANDUM OF POINTS AND AUTHORITIES

Rule 30(d) of the Nevada Rules of Appellate Procedure allows the inclusion of copies of relevant and necessary exhibits in an appendix. However, if an exhibit cannot be reproduced, a party may:

...file a motion requesting the Supreme Court to direct the district court clerk to transmit the original exhibits. The Supreme Court will not permit the transmittal of original exhibits except upon a showing that the exhibits are relevant to the issues raised on appeal, and that the Supreme Court's review of the original exhibits is necessary to the determination of the issue.

NRAP 30(d).

In his Opening Brief, Andrew Young (hereinafter "Young") argues there was insufficient evidence regarding his identification and his intent upon entering the businesses. State's Exhibits 1 and 3, 4, 5, 6, 9, 12, and 13 are videos the jury considered when it identified and decided to convict Young.

Respondent asks that this Court direct the District Court Clerk's office to

transmit State's Exhibit 1, which consists of surveillance footage depicting Young's crimes at the Rampart Casino. State's Exhibit 3 consists of surveillance footage depicting Young's crimes at the Walmart located on East Serene Avenue. State's Exhibit 4 is body camera footage from an officer who cited Young. State's Exhibit 5 is surveillance footage depicting Young's crimes at the Caesar's Hotel and Casino. State's Exhibit 6 is surveillance footage depicting Young's crimes at an Albertsons. State's Exhibit 9 is surveillance footage depicting Young's crimes at the Flamingo Hotel and Casino. State's Exhibit 12 is surveillance footage depicting Young's crimes at the Walmart located on Boulder Highway. State's Exhibit 13 is surveillance footage depicting Young's crimes at the Suncoast Hotel and Casino.

This Court would benefit from watching the videos to understand Appellant's actions and intent which the jury watched when coming to their verdict. Accordingly, this Court should direct the district court to transmit State's Exhibits 1 and 3, 4, 5, 6, 9, 12, and 13 for this Court's review in solving the issues on appeal.

Furthermore, the State also requests this Court direct the District Court Clerk's office to transmit the PSI. The State has utilized the PSI in its Respondent's Appellate Brief when responding to claims 9 and 10. Therefore, the State requests this Court direct the district court clerk to transmit the PSI to this Court, in a sealed envelope, so that this Court may confirm that the reference in the Answering Brief is accurate.

CONCLUSION

For the reasons above, the State respectfully requests the Court to order the District Court Clerk's Office to transmit the PSI and State's Exhibits 1 and 3, 4, 5, 6, 9, 12, and 13
