DECLARATION OF SADMIRA RAMIC

I, Sadmira Ramic, declare under penalty of perjury as follows:

1. I am a Staff Attorney for the ACLU of Nevada.
2. I respectfully request an extension of seven (7) days, up to and including February 28, 2023, which is necessary for me to effectively represent the Respondents' interests in this appeal proceeding.
3. This is the first request for an extension of time to respond.
4. I communicated with opposing counsel, Brett Kandt, via e-mail on February 22, 2023, and he indicated that he has no opposition to Respondents' request for additional time.
5. This extension is necessary for several reasons.
6. First, Appellant raised new issues in its motion that requires additional research to ensure that this Court has adequate information.
7. Second, I am currently in my last stages of pregnancy which has required ongoing medical attention.
8. Third, as the voting rights attorney for our affiliate, my area of expertise is primarily related to voting rights. As such, I have had to dedicate a significant portion of my time to dealing with voting matters that have arisen during the current ongoing Legislative session.

9. Fourth, the same motion, with similar arguments, was made by Appellant in District Court. The motion was denied.

10. Fifth, our office is currently transitioning to a new physical space, and it has caused some disruptions in my ability to respond.

11. This request for an extension is made in good faith, and not for the purpose of delay.
