24 submits a Status Report in Response to this Court's May 14, 2024 Order.

25 **PLEADINGS FILED TO DATE**

26 Since Plaintiff/Appellant's March 11, 2024 Status Report filed by Christine  
27 Webber and since Defendant/Respondent's March 12, 2024 Status Report,  
28 Plaintiff/Appellant's counsel filed a "Notice" of Non-Representation of the Cántaro

1 Castillo Estate in the Federal District Court, [Fed.Dist.Ct. ECF #331], as well as a  
2 Motion to Withdraw as Counsel of Record in the Federal District Court.  
3 [Fed.Dist.Ct. ECF #333] On March 5, 2024, Defendant/Respondent filed a Motion  
4 to Extinguish the Stay imposed by the Federal Court pending determination on the  
5 Certified Question before this Court. [Fed.Dist.Ct. ECF #332] The Federal Court  
6 issued an Order on March 30, 2024, extinguishing the stay. [Fed.Dist.Ct. ECF #335]

7 On April 25, 2024, the Federal District Court Ordered “Plaintiff’s counsel  
8 obtain the addresses of Castillo’s two surviving family members and provide those  
9 addresses to Defendant within 90 days of the date of the entry” of the order... [Fed.  
10 Dist.Ct. ECF #338]

11 On April 26, 2024, Plaintiff/Appellant’s counsel filed a Submission in  
12 Response to Court’s April 25, 2024 Order in Federal Court and provided an address  
13 for the two surviving family members. [Fed.Dist.Ct. ECF #339]
