On May 16, 2024, Respondent DailyPay, Inc., filed a request for judicial notice of the codification of new NRS Chapter 604D, with some intimation of a substantive concern regarding the Petition in this appeal.

Appellants have no objection to judicial notice of the public acts of the Legislative Counsel Bureau (“LCB”). Pursuant to NRS 220.120, however, LCB is empowered to re-order or renumber statutes as needed, to properly identify the effective laws of Nevada, for consistency and ease of comprehension. Appellants are confident that codification of the Petition, if enacted, will be accomplished in an appropriate manner, in relation to all other Nevada laws, without prejudice to the rights of Nevadans to propose and enact statutes by popular initiative.
