**APPELLANT’S REPLY TO OPPOSITION TO MOTION TO SEAL
DOCKETING STATEMENT**

Appellant moved the court to seal Appellant's Docketing Statement that contains references to and copies of pleadings previously ordered sealed on October 14, 2013, by the District Court, out of an abundance of caution. The District Court ordered that all pleadings be sealed on October 14, 2013 pursuant to NRS 125.110. Under NRS 125.110(2), all “papers, records, proceedings and evidence . . . shall, upon written request of either party to the action . . . be sealed.” SCRC 3(4)(a) similarly requires sealing if required by Nevada law. Appellant’s request to seal was done to comply with a District Court order. Having defended against Respondent’s allegations of contempt, Appellant filed this motion out of an abundance of caution.

However, Appellant is cognizant of the fact that Respondent has incurred well over \$50,000 in attorney fees to avoid paying a \$1,200 obligation. Thus, while he

filed his motion to seal out of an abundance of caution, it does not seem economical to continue to incur additional fees fighting the sealing of a docketing statement. Appellant will request leave for any appropriate redactions to the appendix and brief, if even necessary, at the time those filings are due but at this time withdraws the motion for leave to seal the docketing statement (both provided to this Court on August 7, 2023).
