Pursuant to NRAP 26(b)(2), Appellant/Cross-Respondent Pierre A. Hascheff and Respondent/Cross-Appellant Lynda Hascheff, through their respective counsel, stipulate and agree as follows:

On November 16, 2023, Pierre filed his Opening Brief, Appendix Volumes 1-8, a Motion to Take Judicial Notice, and a Motion to Seal Portions of Appellant's Appendix ("Motions").

On November 21, 2023, Lynda's counsel made a telephonic request pursuant to 26(b)(1)(B) for a 14-day extension of time to respond to Pierre's Motions, which was granted that same date. Lynda's responses to the Motions are due on December 11, 2023.

for January 4, 2024 (Lynda's counsel). Additionally, counsel have personal commitments during the intervening holidays. The parties respectfully submit that good cause exists for the requested extension.
