Rule 11 of the Nevada Rules of Civil Procedure states, in pertinent part,

Every pleading, motion, or other paper of a party represented by an attorney shall be signed by at least one attorney of record in his individual name, whose address shall be stated.

The signature of an attorney or party constitutes a certificate by that attorney or party that he or she has read the pleading, motion, or other paper; that to the best of his or her knowledge, information and belief, formed after reasonable inquiry under the circumstances obtaining at the time of signature, that it is well grounded in fact and is warranted by existing law or a good faith argument for the extension, modification, or reversal of existing law, and that it is not interposed for any improper purpose such as to harass or to cause unnecessary delay or needless increase in the cost of litigation. If a pleading, motion, or other paper is not signed, it shall be stricken unless it is signed promptly after the omission is called to the attention of the pleader or movant. (Emphasis added)

The Court wishes to express in the clearest possible terms that the Appellant has requested and been appointed counsel at public expense, and as a result the Court will not entertain documents from the Appellant which are not signed by counsel of record.

NOW, THEREFORE, IT IS HEREBY ORDERED that all above-named submissions filed by the Appellant after June 1, 2004, which do not contain the signature of the Appellant's attorney of record, Mary Lou Wilson, are hereby **STRUCK** from the record for violation of NRCP 11.
