NOTIFICATION TO THE COURT REGARDING THE PETITION FOR RECIPROCAL
DISCIPLINE.

COMES NOW THE RESPONDENT EDWARD E. VARGAS to advise the Supreme Court that Respondent has complied with the terms of the Suspension period in California. (Exhibit 1) Respondent during that same time period also did not practice law in the State of Nevada following in spirit the Petition by the State Bar of Nevada for reciprocal discipline. Attached are the Clark County Court Case sheets showing that Respondent was not practicing law during the California Suspension period. Respondent in fact on June 28, 2005 personally advised Judge Steel of the Clark County Family Court in Court that he believed that the California Suspension applied to him in Nevada cases as well and therefore removed himself from the case at hand.

In June 2005 Respondent contacted David Clark by phone after being unable to contact Rob W. Bare concerning the California Suspension. Respondent advised David Clark that he was intending on not taking on any new Nevada Clients and that he was going to have the few

1 clients he had seek other counsel for the duration of the reciprocal suspension from June 26
2 through August 25, 2005. Respondent went so far as to contact the State Bar Referral and
3 advised them that he believed his suspension from California also covered Nevada cases
4 and the State Bar Referral Service removed the Respondent from their referral lists.

5 Respondent was under the belief that the Reciprocal Petition was automatic. The State
6 Bar of Nevada was made aware of Respondent's intent to honor the California Suspension in
7 Nevada based upon the reciprocal standing. It would be an incredible financial and oppressive
8 hardship to be suspended again from practicing law in Nevada. Respondent has already served
9 a suspension for 60 days in Nevada, concurrently with the California suspension.

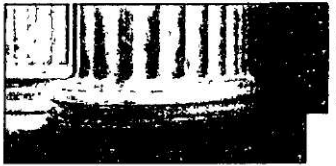
10 It is respectfully requested that the Nevada Supreme Court order a reciprocal and


