CASE APPEAL STATEMENT

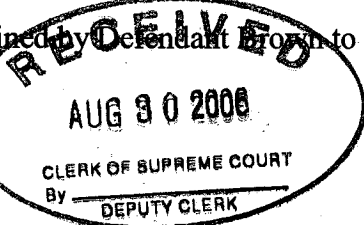
COMES NOW, Defendant, ERICK BROWN, and submits the following Case Appeal Statement:
