

Mr. Buchanan stated he just received the case and wants to know what the Court ruled on the other bad acts.

Ms. Krisko stated she agreed to one battery and did not ask for the other ones to come in because of resolution or dismissal. Court ruled the burglary admissible under the bad acts and set this matter for a petrocelli hearing. Ms. Krisko stated she made an offer of proof under case law to that case (03M25901X), involving the same victim occurring in 2003 and the conviction in 2004.
