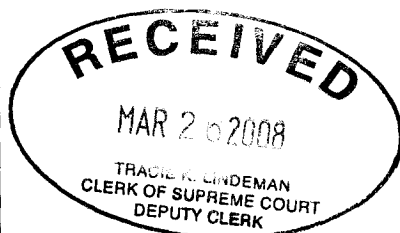
**MOTION FOR EXTENSION OF TIME TO PREPARE AND FILE TRANSCRIPT**

2. On February 21, 2008, I assigned the Request For Transcripts to NW Transcripts.

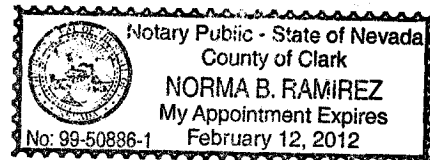
3. That I have spoken with the transcriptionist and she has advised that the transcript is about 75% completed due to a family emergency.
