1	DECLARATION OF AUDREY M. CONWAY
2	1. I am an attorney duly licensed to practice law in the State of Nevada and the
3	Deputy Public Defender assigned to represent TERRENCE KARYIAN BOWSER on appeal
4	currently pending before this Court.
5	2. The Opening Brief was due to be filed on or before Tuesday, August 26, 2008.
6	3. That as of Tuesday, August 26, 2008, declarant has not received the final
7	
8	transcript of 12/05/07 (sentencing hearing). This transcript is a necessary part of the appeal and
9 10	once it is received will need to be reviewed and incorporated into the appendix. In addition, any
10	additional issues will need to be researched and incorporated into the Opening Brief.
12	4. The appendix is also missing numerous other transcripts that declarant was not
13	aware had been filed until today. As declarant was verifying the actual number of missing
14	transcripts, declarant located several transcripts which had inadvertently been misplaced and
15	omitted from the appendix and from declarant's appellate case file. Due to the inadvertent
16	omission of these transcripts from the appendix and the case file, declarant believed they had not
17	been filed. As a result, declarant has yet to review and analyze these transcripts and incorporate
18	any issues related to these transcripts into the Opening Brief.
