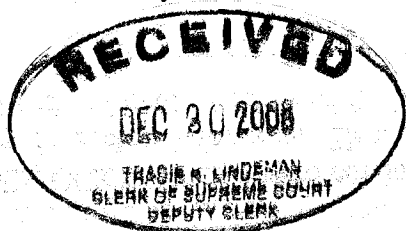

Nevada Certified Court Reporters Board:

I received your correspondence advising me that the Supreme Court had filed a complaint against me regarding my conduct as a court reporter in the case regarding Delarian Wilson, SC Case No. 52104, and that I had 30 days to respond to each item in the complaint.

I contacted the Supreme Court for clarification of their complaint and I was advised that they had not lodged a complaint against me. Nonetheless, I am responding as follows:

The first communication I received regarding this request for transcript was on 10/27/08 when I received a NOTICE TO COURT REPORTER/RECORDER dated 10/21/08 advising me I had 10 days to submit a certificate acknowledging delivery. (See Attachment No. 1.)

I then responded on 10/29/08 stating that that was my first communication and that I would wait for instruction from the Supreme Court. (See Attachment No. 2.)

The Court then responded with their ORDER REGARDING TRANSCRIPTS file stamped November 17, 2008 stating that I had responded that this was my first communication and that a further review indicated Lee Bahr was the court reporter for the 3/28/08 proceedings, and that Lee Bahr and I had 30 days to prepare the transcript, et cetera. (See Attachment No. 3.)

Included in that correspondence was the transcript order that I had never received. (See Attachment No. 4.) On the order there are numerous dates of proceedings requested of J&B Nelson.

At about the same time I received the notice from the Board regarding the complaint (See Attachment No. 5) which included a copy of the Court's order. (See Attachment No. 3.)
