This is in response to your notice of alleged violation dated December 2, 2008. Enclosed please find the following documents:

1. Order regarding transcript received from the Nevada Supreme Court file stamp dated November 17, 2008.
2. Copy of Certificate of delivery to the Supreme Court, which I filed on December 9, 2008.

In the order regarding transcript, you will note that the Supreme Court admonished counsel for not notifying the responsible court reporter, namely, myself, to prepare the transcript of March 28, 2008, and the first three days of the jury trial of Wesley. What is ironic is that I had prepared the 3/28/08 transcript at the request of Mr. Landis, counsel for Mr. Wesley, as quickly as I could, as the jury trial was still going to go forward as to Defendant Narcus Wesley, and I filed said transcript with the Clerk of Court on or about that date. I supplies copies to the D. A.'s office, Mr. Landis's office, Mr. Oronoz's office and filed the original of the 3/28/08 change of plea with the Clerk of Court. However, in my haste, I discovered last Friday, 12/5/08, that I had inadvertently dated page 1 of the transcript March 28, 2007. My certificate page was properly dated March 28, 2008, which is the date on or about which I completed transcribing this 20 page change of plea hearing of Delarian Wilson.

I have, as quickly as I could, prepared the 3 days of jury trial which I court reported before Judge Bixler, April 9, 10 and 11, 2008, and the 803 page, three volume transcript was filed Friday, December 5, 2008 with the Clerk of Court, with copies filed in the Clerk's office to the D. A. Appellate Division, Mr. Oronoz on behalf of Defendant Wilson, and Mr. Winder on behalf of Defendant Wesley.


