# ORDER REGARDING TRANSCRIPTS AND DENYING MOTION AS MOOT

Appellant filed transcript form a request December 11, 2008, requesting that the court recorder for district court Department 7 produce transcripts for certain proceedings. NRAP 9(b), the court recorder had 30 days from that date to deliver the transcripts to appellant and 10 days thereafter to file a certificate with this court acknowledging delivery of the transcripts. The court recorder's certificate was thus due to be filed in this court on January 20, 2009. On that date, court recorder Renee Vincent filed a motion for an extension of time to file the transcripts requested in this appeal. A few days later, on January 23, 2009, Ms. Vincent filed a certificate acknowledging delivery of the requested transcripts for proceedings in district January 30, 2008; February 5, 2008; May 1, 2008; May 12-16 and May 19, 2008; August 7, 2008; August 21, 2008; and October 1, 2008. See NRAP 9(b). Because the certificate was filed, Ms. Vincent's motion is denied as moot. See NRAP 9(c).

The certificate filed by Ms. Vincent does not include two of the dates requested in the transcript request form filed on

December 11, 2008. In particular, the certificate does not mention the proceedings on December 13, 2006, and those on January 24, 2008. Upon review of the district court docket entries and minutes, however, it appears that Ms. Vincent need not produce those transcripts. First, to the extent that appellant sought the transcripts for the grand jury proceedings from December 13, 2006, the district court docket entries indicate that a transcript of those proceedings was filed in the district court on January 8, 2007, and therefore appellant may obtain a copy of that transcript from the district court clerk. To the extent that appellant sought transcripts of the proceedings in district court regarding the return of the indictment on December 13, 2006, we note that Ms. Vincent was not the court recorder present for that proceeding. Second, a review of the district court minutes indicates that there were no proceedings and no court recorder present on January 24, 2008; rather, on that date, the district court entered a minute order. Under the circumstances, we conclude that Ms. Vincent has met her obligations under the transcript request form filed on December 11, 2008.<sup>2</sup>

It is so ORDERED.




