Respondent Gilbert Hyatt ("Hyatt") submits this response to Appellant

Franchise Tax Board of the State of California's ("FTB") May 23, 2016 Motion

for Permission to File Motion in Excess of 10 Pages ("Page Limit Motion").

FTB's Page Limit Motion references the decision of the United States Supreme

Court from this case, *Franchise Tax Bd. of Calif. v. Hyatt*, 578 U.S. ___, 136 S.Ct.

1277, 1283 (2016) ("*Hyatt II*"), and argues that additional pages are needed for

FTB's Motion for Supplemental Briefing Following Mandate from the Supreme

Court of the United States ("Mandate Motion") because the *Hyatt II* decision

"vacated this Court's judgment as unconstitutional." (FTB Motion, at 1).

In so arguing, FTB's Page Limit Motion neglects to clarify that *Hyatt II* addressed only a narrow damages issue and did not address or alter the liability findings or any other portion of the judgment in this case. Specifically, *Hyatt II* held that Nevada cannot award more damages against a California agency for intentional misconduct than Nevada allows against its own agencies. *Hyatt II*, at

1218-83. That is the only error that the United States Supreme Court found with this Court's judgment.¹

FTB's Page Limit Motion therefore incorrectly implies that *Hyatt II* nullified additional findings and conclusions in the judgment entered in this case such that additional pages of briefing are needed for its proposed Mandate Motion. But the holding from *Hyatt II* that this Court's judgment was unconstitutional was singularly focused on the amount of damages that Nevada awarded against FTB, a California agency, and did not affect or reverse the myriad of other findings against FTB that are set forth in this Court's judgment.

While a new final judgment will have to be issued reflecting the more limited damages allowed under *Hyatt II*, the resulting decision in *Hyatt II* does not require oversized briefing to argue the effect of the decision on the new judgment. Hyatt therefore respectfully requests that the Court deny FTB's Page Limit Motion and limit FTB's Mandate Motion — to the extent the Court allows the motion at all

- to ten pages. To the extent the Court grants permission to FTB to file an oversized brief for the Mandate Motion, Hyatt requests that he be granted permission to file a responsive brief of the same size as that of FTB's brief.
