DECLARATION

- I, David Anthony, hereby declare as follows:
- 1. I am an attorney, admitted to the practice of law before this Court. I am employed as an Assistant Federal Public Defender in the Capital Habeas Unit of the Federal Public Defender. I represent the appellant, Michael Damon Rippo, in this appeal.
- 2. Mr. Rippo's petition for rehearing is currently due on March 14, 2016. A request for an extension of time of twenty-one (21) days is sought, up to and including April 4, 2016, in which to file the petition. This is Mr. Rippo's first request for an extension of time.
- 3. Since the filing of the Court's order on February 25, 2016, I have had to devote all my attention to filing deadlines in other capital cases that could not be extended. On February 29, 2016, I filed a petition for writ of certiorari with the United States Supreme Court in Kirksey v. Baker, No. 15-8404 (I was involved in a car accident on February 18, 2016, and I was out of the office on sick leave until February 24, 2016). On March 7, 2016, I filed a petition for writ of certiorari in the United States Supreme Court in Lisle v. Baker, Nev. Sup. Ct. No. 55173. I currently have a post-hearing brief due in McConnell v. Baker, Second Judicial District Court No. CR021938, and I have a petition for writ of certiorari due with the United States Supreme Court on March 21, 2016, in Lopez v. Baker, Nev. Sup. Ct. No. 61535. I

have previously sought and received an extension of time for each of the deadlines

above, and I do not believe that the Court will allow any further extensions of time

for these deadlines.

4. I am requesting three weeks to file the petition for rehearing because I

also have an amended petition due in a complex capital habeas matter arising out of

the Northern District of California on April 8, 2016, in **Bonilla v. Davis**, Case No.

C08-0471 CW. In light of this deadline, I will need to travel to San Francisco and

San Quentin during the week of March 21, 2016.

5. This request is made in order to provide Mr. Rippo with competent

representation, NRPC 1.1, and not solely for the purpose of delay or for any other

improper purpose. I will compete and file the petition for rehearing on April 4, 2016.

I declare under penalty of perjury that the foregoing is true and correct and

that this declaration was executed on March 14, 2016, in Clark County, Nevada.
