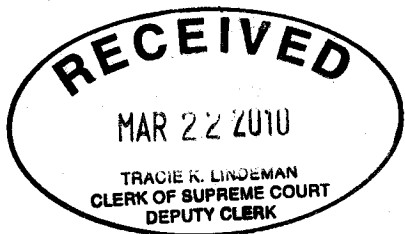
NOTICE OF NON-PAYMENT FOR APPEAL TRANSCRIPTS


