## POINTS AND AUTHORITIES

Due to the importance of getting an *Opposition* on file and Counsel for Real Party in Interests congested schedule, we ask the Court to grant a seven day extension for the filing of our *Opposition*.


Counsel has been required to make several Court appearances on various cases, as well as prepare for, and speak at, a Continuing Legal Education Program on Family Law out of state. We did request an extension from the Court prior to the due date for the *Opposition*. After being informed by a court clerk, that the Court could grant a five day extension or one could be requested by motion, our staff member failed to make it clear that we were requesting the five day extension.

Based on the above, counsel for Real Party in Interest has not had sufficient time within which to properly complete a response to the above motion, and as such, requests an extension of seven days, within which to file such response.

There is no reasonable prejudice to Petitioner if the time required to respond is delayed for seven days. The rules of this Court provide for requested extensions for good cause. Accordingly, we respectfully request an additional seven days within which to file our *Opposition* to Petitioner's *Motion*.


