

20 This matter having come on by *Ex-Parte* Application, the matter having been fully
21 reviewed, and good cause appearing therefore,

22 Luis A. Hidalgo, Jr. (hereinafter "Luis Jr.") was declared indigent by this Court on July 7,
23 2009. Further, Dominic Gentile was appointed Appellate Counsel for Luis Jr., on July 10, 2009,
