#### RESPONSE TO ORDER OF OCTOBER 15, 2010

Respondents Kristi and Anthony Fredianelli hereby respond to the court's order of October 15, 2010.

### Representation by Counsel

On July 21, 2010, Robert Eisenberg filed a notice of association of counsel, indicating that he would be representing respondent Kristi Fredianelli. As this court's October 15, 2010 order recognizes, Eisenberg's subsequent filings indicated that he also represents respondent Anthony Fredianelli, but the court's docket did not indicate such representation.

Eisenberg has now filed another notice of association of counsel, indicating that he will also be representing respondent Anthony Fredianelli in this appeal. In other words, Eisenberg represents Kristi and Anthony Fredianelli in the appeal.

## Anthony Fredianelli's Response to Proper Person Statement

The court's October 15, 2010 order requires Anthony Fredianelli to file a response to the proper person statement not later than October 22, 2010. This portion of the court's order was premised upon the understanding that Eisenberg's response to the proper person statement was only on behalf of respondent Kristi Fredianelli. As indicated in footnote 1 of the response, the response was being submitted as a joint response on behalf of both respondents. Now that Eisenberg has formally entered his appearance as counsel on behalf of Anthony Fredianelli, we believe this satisfies the court's order relating to Anthony Fredianelli's response. In other words, the previous response was filed on behalf
