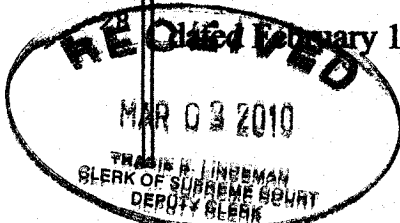

13 **NOTICE OF WITHDRAWAL OF APPEAL**

14 Robert Scotlund Vaile, Appellant in the above mentioned appeal, hereby moves to
15 voluntarily withdraw this appeal.

16
17 The order from an October 26, 2009 hearing in Department I of the Eighth Judicial
18 District Court was entered on December 22, 2009. The notice of appeal in response to
19 this order was received by the Clerk of the Supreme Court on February 9, 2010. At the
20 status hearing following the October hearing, on February 3, 2010, the lower court
21 implied that the December 22 order was intended to be temporary.

23 Furthermore, on February 17, 2010, Appellant filed an emergency motion and
24 Petition for Writ of Mandamus or Prohibition regarding the lower court's rulings during
25 the hearings on October 26, 2009 and February 3, 2010. This Court has, in an order
26 the hearings on October 26, 2009 and February 3, 2010 and Case numbered 55446, stayed matters raised in the petition






