MEMORANDUM

I, STEVEN S. OWENS, am the supervising attorney in the above-captioned case. The State is requesting a thirty (30) day extension of time in which to file its Answering Brief under NRAP 31. No previous extensions have been granted to the State. Defendant received eight (8) extensions of time prior to filing his Opening Brief. As good cause for the extension, the State cites the large size of the record and number of pages in the Opening Brief.

This is an appeal from a district court's Judgment of Conviction entered on May 6, 2009. Appellant filed his Notice of Appeal on March 4, 2010 and filed his Opening Brief on August 2, 2011. Respondent's Answering Brief is due on or before September 1, 2011.

Pursuant to NRAP 26(b), this Court for good cause shown can enlarge the time prescribed by the Nevada Rules of Appellate Procedure for doing any act, or may permit an act to be done after the expiration of such time. In addition, NRAP 31 allows for an initial extension of time of up to thirty (30) days upon a showing of good cause.

This multiple count case, involving several burglary and grand larceny convictions, involves a large record consisting of a four (4) volume appendix—consisting of 831 pages. The twenty-two (22) page Opening Brief raises approximately two (2) main issues and over five (5) sub-issues.

The State respectfully moves for an enlargement of time of thirty (30) days, making said brief due on Monday, October 3, 2011. This will give the State sufficient time to thoroughly review and respond fully to the material in Appellant's Opening Brief.
