Motion to Remand for Appointment of New Counsel

I. This case should be remanded to the district court for the appointment of new counsel.

The appeals in this matter were originally filed by JoNell Thomas and Randy Pike of the Special Public Defender's Office. After this Court issued an order dismissing the appeals, the Special Public Defender's Office was permitted to withdraw as counsel of record. Attorney James Oronoz was subsequently appointed to represent Mr. Flowers for his post-conviction proceedings. At the conclusion of those proceedings, Mr. Oronoz was similarly permitted to be withdrawn as counsel.

The United State District Court, District of Nevada appointed the Federal Public Defender's Office to represent Mr. Flowers in his federal habeas corpus proceedings. Upon learning about a favorable ruling by this Court in a related case (docketed at number 70933), undersigned counsel moved to have the previously dismissed appeals reinstated. This Court granted that motion and ordered the appeals reinstated on July 9, 2018.

On August 16, 2018, this Court issued an order directing Flowers to refile the appendices that were originally submitted with appellate briefs in 2009. Undersigned counsel does not have a copy of the appendices. Counsel contacted the Special Public Defender's Office to inquire if they would be able to comply with this Court's order. JoNell Thomas of the Special Public Defender's Office responded in the negative, stating that her office was no longer counsel on the case and no longer had the file.

Contemporaneous with the filing of this motion, undersigned counsel is filing a motion to be withdrawn as the attorney of record due to a conflict of interest. Therefore, Mr. Flowers respectfully requests his case be remanded to the district court for the appointment of new counsel to assist him with his appeals.¹ The Federal Public Defender's Office can assist new counsel by providing him or her with copies of the case materials currently in our possession.

II. Prayer for relief

Mr. Flowers respectfully requests this Court stay the current order, remand this matter to the district court, and direct that new counsel be appointed.

¹ Mr. Flowers is indigent and he has a constitutional right to the assistance of counsel on direct appeal. *See Kirksey v. State*, 112 Nev. 980, 998 (1996) (citing *Burke v. State*, 110 Nev. 1366, 1368 (1994)).
