SCYPHERS, FRANK SCHARO, SHERIDAN CREEK EQUESTRIAN CENTER, LLC, a Nevada Limited Liability Company, RONALD R. MITCHELL and GINGER G. MITCHELL ("Real Parties"), by and through their counsel, THOMAS J. HALL, ESQ., and file their Opposition to Request for Leave filed herein on September 17, 2010, as follows:

A. The Request For Leave Is Not Authorized.

Rule 21 of the Nevada Rules of Appellate Procedure does not permit the filing of a Request for Leave. Nowhere in Rule 21 of the Nevada Rules of Appellate Procedure is any rule or procedure set forth for the filing a Request for Leave in the form of a Reply. Pursuant to Rule 21(b)(1), the Court ordered an Answer to be filed by the Real Parties which was timely filed on September 13, 2010. No other pleadings, replies or supplements to the record have been ordered by the Court or are allowed.

B. The Writ Petition Is Likely To Be Moot.

Further, the Writ Petition is likely to be moot by the time it is considered by this Court.

As set forth in the Answer filed by the Real Parties in Interest on September 13, 2010, page 14, line 10 through page 15, line 10:

The Order For Division Of Water was filed following an extensive hearing on May 17, 2010. 3 App. 728-748. The Court entered its Order For Division of Water,

specifically limiting the time the Order would be in effect. 3 App. 753-755. See, paragraph 3, which provides as follows:

The Court finds the 21 Day Rotation Schedule attached hereto as Exhibit 1 is a fair and equitable Rotation Schedule for the 2010 irrigation season. [Emphasis supplied.]

Under the Final Order of Determination, the 2010 irrigation season runs from April 1, 2010 to October 15, 2010. See Order of Determination, Period of Use, 1 App. 98-99. Therefore, it is unlikely that this Rotation Schedule will be in effect by the time the Court hears this Petition.

C. This Court Does Not Give Advisory Opinions.

This Court is prohibited from giving advisory opinions. Nev. Const. art. 6 § 4; Applebaum v. Applebaum, 97 Nev. 11, 12, 621 P.2d 1110 (1981) ("This court will not render advisory opinions on moot or abstract questions. Decisions may be rendered only where actual controversies exist."); State Engineer v. Truckee-P.3d 395 (2008).1024, 1032, 13 Irriq., 116 Nev. Therefore, the Writ Petition in Case No. 56351 and the Appeal in Case No. 56551, both filed by the Bentleys, will be moot on October 15, 2010, at the end of the 2010 irrigation season.

Both the Writ Petition and the Appeal filed by the Bentleys should be dismissed.
