6/12/06 – State Engineer entered Preliminary Order of Determination;

4/1/09 - Hon. David R. Gamble designates these proceedings on Bentley's exceptions regarding Sheridan Creek as a separate sub-proceeding – D.

- 10. Nature of Action. This is a water rights adjudication proceeding. Bentley is in a unique position in that it enjoys the right to divert (but not consume) water from Sheridan Creek above its allocated amount pursuant to a Water Diversion and Use Agreement that was recorded in the Official Records of Douglas County, Nevada, on 27 March 1987. The water is to be diverted through Bentley's ponds and then returned to the creek and ditch system for use by other claimants. Intervenors filed multiple motions to have the lower court override that Diversion Agreement and instead impose a rotation schedule. On 18 June 2010, the lower court granted Intervenors' motion(s) and entered an Order which effectively restrained Bentley's diversion of the amount already adjudicated in its favor in the Final Order of Determination and any diversions under the recorded Diversion Agreement; instead, the lower court entered a temporary order for the Office of the State Engineer to implement a twenty-one (21) day rotation schedule on a temporary basis. As a result, Bentley gets the full flow of water from the North Branch of Sheridan Creek 1.6 days out of the twenty-one (21) day rotation cycle. There is no statutory basis or need for this Order, and it was entered without an evidentiary hearing or a requirement for Intervenors to post a bond. Bentley appeals from this Order as if it were a temporary restraining order.
- 11. Other proceedings. Other portions of these proceedings are the subject of an original writ proceeding commenced in the Nevada Supreme Court on 6 July 2010, No. 56351. That writ challenges, *inter alia*, Intervenors' intervention and standing to request any relief. If that

NOW THEREFOR, the Court finds and concludes as follows:

1. NRS 533.230 provides as follows:

533.230. Division of water by State Engineer during time order of determination is pending in district court.

From and after the filing of the order of determination, evidence and transcript with the county clerk, and during the time the hearing of the order is pending in the district court, the division of water from the stream involved in such determination shall be made by the State Engineer in accordance with the order of determination.

2. The Final Order of Determination dated August 14, 2008, on page 193 and 194, under Table 6 for Sheridan Creek - North and South Diversions, states as follows:

The diversion rates for the north and south split of Sheridan Creek are based on a spring and early summer average stream flow of 3.5 c.f.s. Flow and diversion rates during periods of drought and middle to late irrigations season will generally be less than the rates determined in the Preliminary Order of Determination. Therefore, all parties will have to share the water shortage during periods of low flow. The total diversion from either the north or south split can be used in its entirety in a rotation system of irrigation.

- 3. The Court finds the 21 Day Rotation Schedule attached hereto as Exhibit 1 is a fair and equitable Rotation Schedule for the 2010 inrigation spason.
- 4. The Court finds the parties should be ordered to adhere to the 21 Day Rotation Schedule until further order of this Court.

IT IS HEREBY ORDERED, that the State Engineer make division of the water of Sheridan Creek in accordance with the Final Order of Determination dated August 14, 2008 and specifically in

accordance with the attached 21 Day Rotation Schedule commencing immediately and continuing until further order of this Court.

SCYPHERS, THOMAS J. Company, SCHARO, SHERIDAN CREEK EQUESTRIAN CENTER, LLC, a Nevada Limited Liability Company, and RONALD R. MITCHELL and GINGER G. MITCHELL ("Intervenors"), and upon a hearing having been held in this matter on May 17, 2010, with all parties and their counsel present and following the presentation of evidence and argument by counsel, the Court entered its oral order for the Division of Water and the implementation of a Rotation Schedule, and good cause appearing,

NOW THEREFOR, the Court finds and concludes as follows:

1. NRS 533.230 provides as follows:

533.230. Division of water by State Engineer during time order of determination is pending in district court.

From and after the filing of the order of determination, evidence and transcript with the county clerk, and during the time the hearing of the order is pending in the district court, the division of water from the stream involved in such determination shall be made by the State Engineer in accordance with the order of determination.

2. The Final Order of Determination dated August 14, 2008, on page 193 and 194, under Table 6 for Sheridan Creek - North and South Diversions, states as follows:

The diversion rates for the north and south split of Sheridan Creek are based on a spring and early summer average stream flow of 3.5 c.f.s. Flow and diversion rates during periods of drought and middle to late irrigations season will generally be less than the rates determined in the Preliminary Order of Determination. Therefore, all parties will have to share the water shortage during periods of low flow. The total diversion from either the north or south split can be used in its entirety in a rotation system of irrigation.

- 3. The Court finds the 21 Day Rotation Schedule attached hereto as Exhibit 1 is a fair and equitable Rotation Schedule for the 2010 inrigation season.
- 4. The Court finds the parties should be ordered to adhere to the 21 Day Rotation Schedule until further order of this Court.

IT IS HEREBY ORDERED, that the State Engineer make division of the water of Sheridan Creek in accordance with the Final Order of Determination dated August 14, 2008 and specifically in

accordance with the attached 21 Day Rotation Schedule commencing immediately and continuing until further order of this Court.

Mr. Taggert presented closing arguments and presented all parties with an irrigation illustration.




