WHEREAS on September 29, 1993, this court entered an order amending the Supreme Court Rules governing admission to practice, and establishing two committees relating to the admission of applicants to the practice of law in this state, to wit: the Committee on Moral Character and Fitness to Practice Law, and the Committee on Functional Equivalency;

WHEREAS it appears necessary to this court that the bar admissions process, particularly the organization and functions of these two new committees, be subject to further study and review prior to the adoption of rules permanently establishing the two committees;

WHEREAS the terms of the Chair of the Board of Bar Examiners, the Committee Chairs, and the court-appointed members of the Committees shall expire October 1, 1994, pursuant to the Order of Appointment entered November 17, 1993;

WHEREAS it is vital that the work of Board of Bar Examiners and these two committees continue uninterrupted during the period of study and review of the bar admissions process;

IT IS HEREBY ORDERED that Ronald D. Alling is reappointed to serve as the Chair of the Board of Bar Examiners;

IT IS HEREBY FURTHER ORDERED that Ronald D. Alling, by virtue of his position as Chair of the Board of Bar Examiners, shall serve as an "ad hoc" member of both the Committee on Moral

IT IS HEREBY FURTHER ORDERED that Keith Lee is reappointed to serve as the Chair of the Committee on Moral Character and Fitness to Practice Law;

IT IS HEREBY FURTHER ORDERED that Thomas Beatty is reappointed to serve as the Chair of the Committee on Functional Equivalency;
