TO: THE HONORABLE CHIEF JUSTICE AND ASSOCIATE JUSTICES OF THE SUPREME COURT OF THE STATE OF NEVADA:

COMES NOW, Ronald D. Alling, Chairman of the Nevada Board of Bar Examiners (the "Board"), and hereby respectfully petitions this Honorable Court as follows:

This Court did, in 1992, appoint C. Robert Cox to the Board to serve a two-year term, and reappointed said C. Robert Cox to a three-year term in 1994.

II.

That the said C. Robert Cox' term will expire in this calendar year 1997; however, he is ready, willing and able to be reappointed to serve an additional term of three years.

The said C. Robert Cox is eligible to serve an additional three-year term without violating the lifetime limit of nine (9) years as imposed by SCR 49(3).

IV.

This Court did, in 1993, appoint Allen R. Earl to the Board to serve a one-year term, and reappointed said Allen R. Earl to a three-year term in 1994.

V.

That the said Allen R. Earl's term will expire in this calendar year 1997; however, he is ready, willing and able to be reappointed to serve an additional term of three years.

VI.

The said Allen R. Earl is eligible to serve an additional three-year term without violating the lifetime limit of nine (9) years as imposed by SCR 49(3).

VII.

The undersigned, Ronald D. Alling, was appointed by the Board of Governers, and has served on the Board since 1985, and been Chairman since 1994, and pursuant to SCR 49(3) is not eligible for reappointment.

VIII.

Karen A. Peterson has served on the Board of Bar Examiners as the Board of Governers appointee since 1990, is the a senior member thereof, and has served as Vice-Chairperson of the Board for the year last past, and is ready,, willing and able to accept this Court's appointment as chair.

WHEREFORE, the undersigned prays as follows:

- 1. That the said C. Robert Cox be appointed by this Honorable Court for an additional three-year term ending in the calendar year 2000;
- 2. That the said Allen R. Earl be reappointed by this Honorable Court for a three-year term expiring in the year 2000;
- 3. That this Honorable Court appoint Karen A. Peterson as Chairperson of the Nevada Board of Bar Examiners until 1999, the duration of her term on the Board.
 - 4. For such other and further relief as the Court deems just and proper herein.
