ORDER IMPLEMENTING AMENDMENTS TO  
RULE 49 OF THE SUPREME COURT RULES

On April 8, 2002, this court issued an order amending Rule 49 of the Supreme Court Rules and specifying, among other things, that the board of bar examiners shall be composed of 11 active members of the state bar. In addition, our order repealed the limitation on the number of terms an attorney may serve on the board of bar examiners.


In order to implement these changes to the board of bar examiners and maintain the staggered terms required by SCR 49(5), adjustment of the terms of the current board members is required; accordingly,

IT IS HEREBY ORDERED that the terms of the 11 current members of the board of bar examiners shall expire in October in the year designated as follows:

IT IS FURTHER ORDERED that, in accordance with SCR 49(2), the board of governors shall appoint such new members to the board of bar examiners as are necessary to fill vacancies occurring in seats designated D, E, H, J and K, and the supreme court shall appoint such new members to the board of bar examiners as are necessary to fill vacancies occurring in seats designated A, B, C, F, G, and I.


