ORDER IMPLEMENTING AMENDMENTS TO  
RULE 49 OF THE SUPREME COURT RULES

On April 8, 2002, this court issued an order amending Rule 49 of the Supreme Court Rules and repealing the limitation on the number of terms an attorney may serve on the moral character and fitness committee.

In order to implement these changes to the moral character and fitness committee and maintain the staggered terms required by SCR 49(5), adjustment of the terms of the current committee members is required; accordingly,

IT IS HEREBY ORDERED that the terms of the 9 current members of the moral character and fitness committee shall expire in October in the year designated as follows:
