ORDER IMPLEMENTING AMENDMENTS TO
RULE 49 OF THE SUPREME COURT RULES

On April 28, 2004, this court issued an order amending Rule 49 of the Supreme Court Rules by increasing the number of members on the board of bar examiners from 11 to 14 active members of the state bar. In order to implement these changes to the board of bar examiners and maintain the staggered terms required by SCR 49(5), it is necessary to create three new seats on the board and stagger the expiration dates of these new seats. Accordingly,

IT IS HEREBY ORDERED that three new seats on the board of bar examiners shall be created and designated as seats L, M and N;

IT IS FURTHER ORDERED that, in accordance with SCR 49(2), the board of governors shall appoint such new members to the board of bar examiners as are necessary to fill vacancies occurring in the seat designated L, and the supreme court shall appoint such new members to the board of bar examiners as are necessary to fill vacancies occurring in the seats designated M and N.


IT IS FURTHER ORDERED that John P. Desmond is appointed as a member of the board of bar examiners to fill seat M and his initial term on the board shall expire in October 2007;


IT IS FURTHER ORDERED that Lynn S. Fulstone is appointed as a member of the board of bar examiners to fill seat N and her initial term on the board shall expire in October 2008;


IT IS FURTHER ORDERED that the initial term of the member of the board of bar examiners appointed by the board of governors to fill seat L shall expire in October 2006.


