WHEREAS, in October 2007, the Judicial Council of the State of Nevada (JCSN) approved an interim Committee to study revisions to the standardized protection order forms for domestic violence cases in all courts in the State of Nevada; and

WHEREAS, on October 24, 2008, the Standardized Protection Order Forms Committee filed with the JCSN recommendations for the approval of various standardized protection order forms related to domestic violence cases. The court approved the proposed forms on December 5, 2008. The Committee having completed its assigned tasks, this court held it in abeyance upon approval of the forms; and


WHEREAS, the Standardized Protection Order Forms Committee was subsequently tasked to review the standardized protection order forms in light of new legislation, and, on September 24, 2010, the Committee filed with the JCSN recommendations for the approval of various standardized protection order forms related to victims of stalking and harassment. This court approved the proposed forms on December 27, 2010. The Committee having completed its assigned tasks, this court held it in abeyance upon approval of the forms; and


WHEREAS, this court has determined that the Committee should be reconvened to study and update the standardized protection order forms based on current statutes and technologies; accordingly,

IT IS HEREBY ORDERED that the Committee be reconvened to study and propose updates to the standardized protection order forms for this court's consideration;


IT IS FURTHER ORDERED that the individuals listed in Exhibit A are appointed to the Committee.
