

ORDER APPOINTING STUDY COMMITTEE

On December 19, 1989, a petition was filed requesting that this court appoint a committee to work with the subcommittee of the Legislative Commission established by S.C.R. 46 of the sixty-fifth session to study the feasibility of adopting alternative procedures for resolving civil disputes in this state. It appears that further study of the matters presented in the petition is necessary. Therefore, pursuant to NRAD 4.3(c),

IT IS ORDERED that the issues presented in the petition in ADKT 126 shall be referred to a study committee.

IT IS FURTHER ORDERED that the persons listed in Exhibit A, attached hereto and incorporated herein by this reference, shall be appointed to the study committee.

IT IS FURTHER ORDERED that the committee shall consider and prepare recommendations concerning a comprehensive system of court rules and statutes that will alleviate the burdensome costs and delays that currently plague the judicial system of this state.

IT IS FURTHER ORDERED that the committee shall present

its findings and recommendations to this court on or before
September 1, 1990.
