ORDER APPOINTING IMPLEMENTATION COMMITTEE

On December 20, 1989, this court created a committee to work with a subcommittee of the Legislative Commission in a cooperative effort to develop a comprehensive system of statutes and court rules to alleviate the burdensome costs and delays that currently plague the judicial system. The committee submitted its final report to this court on November 29, 1990.

On February 22, 1991, this court approved, on an experimental basis, a set of rules establishing a court-annexed mandatory, non-binding system of arbitration. We noted in that order that we would appoint a committee to aid in the implementation of the rules and to monitor the performance of the rules. Therefore,

IT IS HEREBY ORDERED that a committee be appointed to aid in the implementation of the arbitration rules and to monitor the performance of those rules. The persons listed in Exhibit A, attached hereto and incorporated herein by this reference, are appointed to the committee.

IT IS FURTHER ORDERED that the committee will report its progress monthly to the court, unless the court requests otherwise.
