O R D E R

On March 12, 1991, this court entered an order appointing a committee to aid in the implementation of rules establishing a court-annexed, mandatory, non-binding system of alternative dispute resolution. On October 2, 1992, the current Chairman of the ADR Implementation Committee, A. William Maupin, submitted to this court the committee's first formal report. Consistent with recommendations contained in the committee's first formal report,

IT IS HEREBY ORDERED that a General Implementation Subcommittee be appointed to evaluate the efficiency and progress of the ADR program. The persons listed in Exhibit A, attached hereto and incorporated herein by this reference, are hereby appointed to the subcommittee.

IT IS FURTHER ORDERED that, commencing from the date of this order, the subcommittee shall file a formal report with the clerk of this court at six (6) month intervals, unless the court requests otherwise.
