ORDER VACATING ORDER ENTERED JUNE 22, 1995

AND

AMENDED ORDER APPOINTING ATTORNEY ARBITRATORS

AND NON-ATTORNEY ARBITRATORS

On May 30, 1995, and June 12, 1995, the State Bar of Nevada transmitted to this court letters certifying that certain Nevada attorneys had completed the State Bar arbitration program and were qualified to serve as arbitrators pursuant to Nevada Arbitration Rule 7. This court accordingly entered an order on June 22, 1995, appointing the certified attorneys to the panel of attorney arbitrators assigned to the Court Annexed Arbitration Program.






