



ORDER APPOINTING ATTORNEY ARBITRATOR

The following individual has applied to this court for appointment to the attorney panel of arbitrators, and the State Bar of Nevada having investigated the applicant's qualifications and fitness to serve as an arbitrator;

It appears to the court that the following individual is qualified to serve as an arbitrator pursuant to Nevada Arbitration Rule 7; however, he has not completed the arbitrator orientation and training program mandated by NAR 7(C). Because the requisite orientation and training sessions are infrequently offered by the State Bar of Nevada, this individual may nonetheless serve as an arbitrator. But he must successfully complete the next available arbitrator training offered by the State Bar of Nevada in order to remain on the panel of arbitrators:

IT IS THEREFORE ORDERED that the individual listed above may be sworn or affirmed as provided in NAR 7, and shall submit his oath to the arbitration commissioner for the judicial district where he will serve

as an arbitrator. The arbitration commissioner shall maintain a list of active members of the panel of arbitrators as required by NAR 7.


