



*ORDER APPOINTING ATTORNEY ARBITRATOR*

The following individual has applied to this court for appointment to the attorney panel of arbitrators, and the State Bar of Nevada having investigated the applicant's qualifications and fitness to serve as an arbitrator;

It appears to the court that the following individual is qualified to serve as an arbitrator pursuant to Nevada Arbitration Rule 7; however, she has not completed the arbitrator orientation and training program mandated by NAR 7(C). Because the requisite orientation and training sessions are infrequently offered by the State Bar of Nevada, this individual may nonetheless serve as an arbitrator. 
