ORDER RE: PILOT PROGRAM IN CIVIL APPEALS

On June 13, 2005, this court established a one-year pilot program for processing civil appeals filed by proper person litigants. The pilot program allows proper person litigants to participate in civil appeals and provides form documents to assist these litigants.

Pursuant to our order entered June 10, 2005, all civil appeals involving proper person litigants docketed on or after June 13, 2005, are automatically entered into the pilot program. In addition, all further proceedings in civil appeals pending before June 13, 2005, are subject to the pilot program unless, in the opinion of this court, its application in a particular pending action is not warranted or feasible.

It appears that a revised version of the pilot program Civil Proper Person Appeal Statement form is needed in order to effectively process civil appeals that were pending before June 13, 2005. Accordingly, the court adopts the form attached hereto as Exhibit A for distribution to proper person appellants in those cases.

Forms cannot be faxed or e-mailed to the Nevada Supreme Court Clerk's Office.

Copies of the completed form must be mailed or delivered to the other parties to this appeal or to the parties' attorneys, if they have attorneys. You must also fill out the certificate of service that is attached to the form. The Nevada Supreme Court may return any document that does not meet these requirements.
