ORDER ESTABLISHING STUDY COMMITTEE
ON PRESERVATION, ACCESS AND SEALING OF COURT RECORDS

Pursuant to the Nevada Rules on the Administrative Docket, and in response to the Nevada Supreme Court's concerns about the lack of standardized policies and procedures concerning the preservation, public access, and sealing of court records, we hereby create a study committee to be known as the Commission on Preservation, Access and Sealing of Court Records. The Commission shall conduct hearings and examine the issues involving access to court records and the need to balance public access with private interests, and, in light of those considerations, recommend to this court appropriate statewide policies and procedures.

Further, the individuals listed on Exhibit A are hereby appointed as members of the Commission on Preservation, Access and Sealing of Court Records and District Judge Brent T. Adams shall serve as

chair of the Commission. The method and approach for the Commission's investigations shall be determined by the Commission.
