Pursuant to the Nevada Rules on the Administrative Docket, and in response to the Nevada Supreme Court's concerns about the lack of standardized policies and procedures concerning the retention of court records, we hereby reconstitute the Commission on Preservation, Access and Sealing of Court Records. The Commission shall conduct hearings and examine the issues involving the retention of court records and, in light of those considerations, recommend to this court appropriate statewide policies and procedures.

Further, the individuals listed on Exhibit A are hereby appointed as members of the Commission on Preservation, Access and Sealing of Court Records and the Honorable James W. Hardesty, Associate Justice, shall serve as chair of the Commission. The method and approach for the Commission's investigations shall be determined by the Commission.
